WHEREAS, the Crawford County Board of Supervisors, after consulting with the Crawford County Engineer, desire to designate the following road to be classified as Area Service C, and

WHEREAS, pursuant to Notice of Public Hearing duly published according to the Iowa Code, Public Hearing as held on October 22, 2024 at 10:00 a.m. in the Board of Supervisors room at the Crawford County Courthouse, Denison, Iowa, to hear support and/or objections from the public on road so designated.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF CRAWFORD COUNTY that this County does hereby establish the roads described as Area Service "C" roads with restricted access and a minimal level of maintenance.
