The Board of Supervisors met at 9:00 o'clock A.M. with Dave Muhlbauer, chair presiding. Members present were Schultz, Dozark, Muhlbauer, Heiden, and Rosburg.

Minutes of the previous meeting were read and approved.

A motion was made by Dozark, seconded by Heiden to approve the 2025 Dust Control Applicator Agreements.

Motion passed unanimously.

A motion was made by Rosburg, seconded by Dozark to approve the following resolution:

Resolution No. 2025-12  
Detour for closing a numbered route.

WHEREAS, Section 306.41 of the Code of Iowa 2014, provides that any County numbered road, closed for over forty-eight hours, shall have a designated detour route, and

WHEREAS, Construction Project BRS-7927(602)--60-24 will require that County Route M55 between US Hwy 30 and 350<sup>th</sup> St. be closed to all traffic for several months because of a bridge replacement project.

NOW THEREFORE BE IT RESOLVED by the Crawford County Board of Supervisors that the following described route be designated as a DETOUR and that signs be erected accordingly for the duration of the construction, as determined by the County Engineer:

The DETOUR shall commence at the junction of County Road M55 and US Hwy 30, thence West 7.8 miles on US Hwy 30 to County Road M36 (AKA Donna Reed Road), thence South and East 4.9 miles on County Road M36 to County Road E53 (AKA S Ave.), thence East 4 miles on County Road E53 to junction of County Road E53 and County Road M55 (AKA 330<sup>th</sup> St.).

BE IT FURTHER RESOLVED that upon completion of the construction work, as determined by the County Engineer, the DETOUR shall be terminated without further action by this Board.

Voting Aye: Schultz, Dozark, Muhlbauer, Heiden, and Rosburg. Motion passed unanimously.

Allen Olson, Manilla Economic Development Committee, had a discussion with the Board about helping with funding for the Manilla Wellness Center. The Center needs HVAC and roofing replacements. No action was taken at this time.

A motion was made by Schultz, seconded by Heiden to approve the liquor license for Copper Ridge Farm, LLC.

Motion passed unanimously.

At 12:05 o'clock P.M. the Board took a recess.

The Board reconvened at 1:05 o'clock P.M. to meet with Public Health and Landfill Departments for Budget Work Sessions.

On motion duly seconded the Board adjourned at 3:19 o'clock P.M.
